REPORT OF THE EDITOR FOR 1966

INTRODUCTION

On November 1 the major part of the activities of the editor's office was transferred to the direction of the new editor, Dr. William T. Holser.

The main responsibilities that remained to me included:

1. The November–December number, including the index for 1966.
2. Manuscripts that were received prior to November 1, and which are "in progress," in the sense that they are either in the hands of referees selected by me or have been returned by me to the author for revision. The total number of such manuscripts, as of November 1, was 44 major and 10 notes manuscripts. By January 1, 1967, the total of such manuscripts awaiting final processing was 30. The following report included statistics for all of 1966, but the new editor will report his activities at the end of 1967.

PUBLICATION RESULTS

The Mineralogical Society of America has published during 1966 the following numbers of *The American Mineralogist*:

The August number was a special number entitled "Index of New Mineral Names, Discredited Minerals and Changes of Mineralogical Nomenclature in Volumes 1-50 of *The American Mineralogist*," and is largely the result of Michael Fleischer's indefatigable efforts in indexing and classifying the enormous amount of data contained in our continuing publication, "New Mineral Names," prepared largely by him or under his direction since 1940. The Society and indeed all mineralogists will be indebted deeply to Dr. Fleischer for arranging this information in such highly usable form in an index and in tables.

During the last six years *The American Mineralogist* underwent a period of major expansion and changes. The publication results for this period are as follows:

Numerous other changes also have taken place:

1. A statement of editorial policy was developed (inside front cover).
2. A system of regular selection and rotation of associate editors was developed and put into effect.
3. A rigorous system of critical review of MSS was instituted and a list of reviewers was developed.
4. Standardization of style (headings, punctuation, abbreviations, symbols, references, etc.) was placed into effect.
5. All MSS involving new mineral names or descriptions of new species are now reviewed by the Commission on New Minerals and Mineral Names, I.M.A.
6. A list of rules and suggestions to authors was made up to assist in increasing the quality of MSS ("Preparation of Manuscripts—Instructions to Authors").
7. The mechanics of handling MSS editorially was greatly streamlined with the introduction of standardized records and forms.
8. The files of the editorial office were completely reorganized and a number of items were sent to Dr. George T. Faust for inclusion in the Archives of the Society.
9. Changes in the format of *The American Mineralogist* included:
 - a. New cover arrangement
 - b. New color for cover stock
 - c. "Notes and News" changed to "Mineralogical Notes"
 - d. The March-April number was split into two parts
 - e. The book review section was expanded.
10. The task of sending out back numbers was transferred to the treasurer's office.
11. The complete handling of advertisements was transferred to an Advertising Manager. For these arrangements I am particularly grateful to Martin and Rita Ehrmann, and to the present Advertising Manager, Mrs. Marion Godshaw.

12. The journal was placed under copyright protection.
13. A new schedule of MS submission and galley proof return was developed with George Banta Co.
14. Two special numbers appeared
 - a. "Kerr Number"—Vol. 50, No. 10, October 1965
 - b. "Index of New Mineral Names, etc." by Michael Fleischer—Vol. 51, No. 8, August 1966.
