## REPORT OF THE TREASURER

Ending July 31, 1971

The Treasurer's report is given on a cash basis and the period reported is from August 1, 1970 to July 31, 1971. The major increases of expenses in this past year over that of the previous year are reflected in an increase in cost of the journal publication, which amounted to about 10%. Another added expense was in the administration category which involved the taking over by AGI of the full secretarial office duties. The third item of expense was the publication of Special Paper #3. This involved the borrowing of \$20,000 from Riggs National Bank in Washington at 7% interest. I am happy to report that all but \$3,500 of the borrowed money has been paid back to the bank. We will retire this debt before the end of the calendar year 1971. The monies used to repay this debt involved income from stock investments and income from the sale of the Special Papers.
